



Marlon Truck Deck & Accessory Warranty

Marlon Recreational Products Ltd. warrants each new **Marlon Truck Deck** to be free from defects in materials and workmanship for a period of two (2) years from date of purchase or three (3) years from the date of manufacturer. **Marlon** shall repair or replace, without charge, any parts found to be defective because of imperfect workmanship or materials, within a reasonable time after the deck is returned at purchaser's expense to any **Marlon Deck** authorized distributor or dealer.

Warranty Conditions

Marlon Recreational Products Ltd., warrants that the Marlon manufactured products and accessories will be free from material manufacturing and material defects for a period of two (2) years following the original retail purchase date or three (3) years from the date of manufacturer. Truck deck will be free from structural defects for a period of three (3) years from the time of manufacturer.

Who is covered?

This warranty is extended to the original purchaser only and does not extend to any other persons to whom the deck may be transferred.

Purchased parts such as lights, Putco rear load bar light, superglides and superclamps are covered based on the particular manufacturer's discretion.

What is not covered? Any items that were found modified or altered in any way; nor shall the warranty apply to any defect or malfunction which was caused by damage, unreasonable use, or failure to provide reasonable and necessary maintenance.

The warranty will not cover damage caused by overloading the deck or its components beyond stated capacities or improper weight distribution. Marlon decks are designed to carry 2,000lbs evenly distributed over the deck surface.

Due to the highly corrosive conditions a deck is exposed to, rust formation is not covered.

Other Limitations This warranty does not cover variations in factory applied paint, abrasion due to loading and unloading machines or cargo on a **Marlon Deck**, UV/chemical degradation of finished surfaces or plastic or electrical components, or normal wear and tear from use. Wood decking has no warranty. Installation of the deck is not covered under warranty. Some plastic components are designed as wear surfaces and as such will be consumed in normal use. These consumable components can be purchased through an authorized dealer, distributor or directly from Marlon.

Marlon Recreational Products Ltd. makes no claims or warranties whatsoever to a particular vehicle's ability or capacity's and is not responsible for increased wear or failure of the vehicles

components when operated with a Marlon Truck Deck. The load capacity of the deck applies to the Marlon Deck only – see vehicles manufacturers specifications.

Some states do not allow limitation on how long an implied warranty lasts, so the above limitation may not apply to you. The use of any unit as part of a rental fleet, or use for commercial purposes voids this warranty.

Owners Responsibilities

Incidental or consequential damage or loss of cargo or profit due to use, neglect, lack of maintenance, misuse, or abuse of the Marlon deck is the sole responsibility of the user and excluded from any warranty remedy. When using a Marlon deck the extendable sides must be locked into position. Safety pin placed into the telescopic ramp when being used. All cargo should be secured to the deck surface in accordance with State, Provincial and Federal laws. All clamps and fastening devices should be checked prior to use.

Owner must register the Marlon Deck within 45 days of purchase at www.marlonproducts.com under warranty registration.

The following are exclusions of **Marlon Deck** Warranty:

- Loss of time
- Inconvenience
- Towing charges
- Travel expenses
- Lodging
- Telephone
- Gas
- Loss or damage to personal property or loss of wages

Marlon Recreational Products Ltd. shall not be liable for any incidental or consequential damages for breach of this or any other warranty expressed or implied.

Warranty Claims

In the event of a warranty product failure a claim may be made to Marlon Recreational Products Ltd., and a representative of the company will inspect the product or request certain pictures of the product. If a manufacturing, material, or structural defect is determined to exist Marlon will, at its discretion, provide the exclusive remedy of repair or replacement of the defective component. Marlon is not responsible for any transportation costs associated with a warranty claim.

This warranty shall be considered void if the product is shown to have been abnormally used, misused, not maintained, or altered in any way. There is no implied warranty of merchantability or implied warranty of fitness for any particular purpose. Any such warranties are disclaimed. This warranty is the only warranty applicable to the Marlon Truck Deck products and may not be changed in any way without written authorization from an officer of Marlon Recreational Products Ltd.
